**IMPORTANT NOTES:**

**The final pavement repair must be completed by August 31<sup>st</sup> of the year following the excavation** (i.e., an excavation done before December 31, 2024 must have the final pavement installed by August 31, 2025). Contractors are responsible to maintain the trench after permanent restoration until the road is paved by the city or state. Should the permanent pavement repair fail the contractor will be responsible for repair.

**One open travel lane in the area of the excavation must be maintained at all times to ensure two-way travel. Contact dispatch at 207-874-8575 if this provision cannot be maintained each day.** Sketch allows the inspector/reviewer to quickly determine the location of the excavation and any possible issues. A sketch shall include: street name and address, utility being installed (if there are multiple utilities please show all in sketch)
