

## INVITATION TO BID

City of South Portland, Maine

Sidewalk and Pedestrian Safety Improvements  
Cottage Road, Broadway, and Waterman Drive

Bid #01-21

Sealed bids for construction of the Cottage Road, Broadway, and Waterman Drive Improvements (Bid #01-21) will be received by the City of South Portland Purchasing Agent at the South Portland City Hall until **June 24, 2020 at 2:00 p.m.**, local time and then at said office publicly opened and read aloud. Bids submitted after this time will not be accepted. Each bidder must submit a single sealed envelope, the outside of which must be clearly marked "Bid for Sidewalk and Pedestrian Safety Improvements, Cottage Road, Broadway, and Waterman Drive (Bid #01-21)".

### **Location**

These sidewalk and pedestrian improvements are located along Cottage Road from Pine Street to Sawyer Street, Broadway from Anthoine Street to Elm Street, and Waterman Drive from Broadway to Erskine Drive in South Portland.

### **Outline of Work**

The work includes: the reconstruction of existing concrete and bituminous sidewalks, the installation and reset of granite curbing, some closed drainage improvements, the installation of solar powered Rectangular Rapid Flashing Beacons (RRFB's) and other pedestrian signal equipment, and associated work as shown on the contract drawings and documents.

### **Basis of Award**

This Contract shall be awarded to the responsible bidder whose bid, complying with conditions and requirements provided in this Notice and Bid Form, is the lowest bid as defined in the Bid Form.

### **Other Information**

The Contractor shall make note of the other requirements presented in the contract documents. The Contractor shall be aware that they may commence this work at any time following the contract award, but must complete the work by November 15, 2020.

**The Issuing Office is Sebago Technics, 75 John Roberts Road, Suite 4A, South Portland, ME 04106.** Copies of Contract Documents may be obtained upon payment of a fee of **\$75.00** per set. Plans and specification will be available on **June 1, 2020 after 10:00 a.m.** Partial sets will not be distributed. All requests for mailed documents must be accompanied by an additional non-refundable fee of **\$25.00** to cover postage and handling. **Checks should be made payable to SEBAGO TECHNICS. Credit cards will not be accepted.**

To be considered a responsive Bidder, the Contractor shall have obtained at least one set of paper plans and specifications from the Engineer (Sebago Technics). The Bid will not be awarded to a Bidder unless a record for the purchase of at least one set of paper plans and specifications exists in the office of the Engineer. To meet this requirement and to establish the record of purchase, a prospective Bidder must purchase paper plans and specifications using the name that is to appear in the Bid Documents.

**A Pre-Bid Conference** will not be held for this project.

All questions are to be submitted to Engineer in writing. Questions may be transmitted by e-mail to [skelly@sebagotechnics.com](mailto:skelly@sebagotechnics.com). Questions received less than 5 working days prior to the date for opening of Bids may not be answered. Only questions answered by Addenda will be binding.

A bid must be accompanied by Bid security made payable to Owner in an amount of 5% of Bidder's maximum bid price and in the form of a certified check or Bid bond issued by surety meeting the requirements of the General Conditions. No bid may be withdrawn for at least 60 days after receipt of bids unless released by the Owner.

Within five days after the receipt of bids, the apparent low responsive bidder shall deliver to the Engineer and Owner for review and acceptance the listing of subcontractors, suppliers or entities for the work listed in Supplementary Condition SC-7.06.

The successful bidder must furnish within **10 calendar days** after the Notice of Award the required number of copies of the **signed Agreement, 100% Performance Bond, 100% Payment Bond, Insurance Policy** and begin execution of this contract within 10 calendar days following the Notice to Proceed. **The Contractor shall be responsible for the full amount the 100% Performance Bond and the 100% Payment Bonds. Combining bonds of subcontractors is not acceptable.**

The Successful Bidder must comply with the following:

Failure of the successful bidder to complete the pre-award requirements of this program may result in finding that the bidder is non-responsible and therefore not entitled to award of this contract.

The Owner reserves the right to reject any or all Bids, to waive any technical or legal deficiencies, and to accept any Bid that it may deem to be in the best interests of the Owner.
