PURCHASE AND INSTALLATION OF 7 YARD DUMP BODY

Sealed bids for THE Purchase and Installation of a 7 Yard Dump Body for the City of South Portland Sewer Maintenance Department as specified below and in the attached proposal will be received by the City Purchasing Agent, Room 105, City Hall, 25 Cottage Road, South Portland, Maine until **2:00 P.M., Monday, December 30, 2013** at which time they will be publicly opened and read aloud. Proposals received after above stated date and time will not be considered.

Bids shall be submitted on the attached bid form in sealed envelopes, plainly marked "Bid #19-14 for Dump Body" and shall be addressed to the Purchasing Agent at the above address.

Delivery to be made upon receipt of purchase order and shall be F.O.B., Sewer Maintenance Department, 1142 Highland Avenue, South Portland, Maine.

All equipment offered on this bid shall be brand-new and the latest type available. Bidder will state in his bid the name and model number of the equipment he is offering and will include with his bid a catalog or brochure marked to indicate the standard factory equipment of the model on which he is bidding. Bidder must attach a separate sheet to his bid listing any deviation from the minimum specifications shown. If no attachment is provided, it will be assumed that the item being bid meets the minimum specifications.

If the equipment offered by a bidder under the attached specifications meets the specifications except for minor factors or reasonably small amounts in dimensions, and if it shall be determined by the City that these minor variations from the specifications do not prevent the equipment being bid from performing as satisfactorily or from being as good as equipment fully meeting these specifications, then these minor variations from the specifications may be waived by the City, if it deems it to be to its advantage, and the equipment with the waived variations in specifications will be accepted as fully meeting these specifications.

It is the custom of the City of South Portland to pay its bills within 20 to 30 days following delivery of and receipt of bills for all items covered by the purchase order. In submitting bids under attached specifications bidders should take into consideration all discounts, both trade and time, allowed in accordance with the above payment policy. All bidders should quote net prices, therefore, exclusive of all Federal Excise Taxes.

The City of South Portland reserves the right to waive all informalities in bids, to accept any bid or any portion thereof, or to reject any or all bids should it be deemed in its best interest to do so. Except as otherwise required by law or as specifically provided to the contrary herein, the award of this bid shall be governed by the City's purchasing ordinance.

General: The City is seeking a new, currently advertised 7 cubic yard dump body to be installed on a 2006 Freightliner, M2106 chassis with proper CA and automatic transmission. The dump body must be new and produced by an established manufacture. No used or demo body's will be accepted. New PTO and pump shall be included in price. Body paint shall match existing cab color code. Smooth sides or vertical side post with horizontal braces are acceptable body styles for this bid.

Individual Components and Specifications

- Dimension: 10' length x 84" wide, 30" side height, and 40" end height
- Sides: Minimum 8 gauge smooth steel constructed with full depth rear post & rear bolster or Vertical side posts with horizontal side braces also acceptable.
- Floor: ¼" AR450 heavy duty steel floor: with 6" long sills and 4" X-sills on 12" centers or unibody construction
- Tailgate: manual water tight with rubber seals and (2) turn buckles high Ten. tailgate with (3) coal doors
- Apron: 10" 8 gauge steel construction, bolt on type
- Cab Shield: 1/2X84" 10 gauge steel
- Pump & Hoist: U860D DA hoist with G105-1 pump and Hot-shift PTO, Front inverted telescope hoist also acceptable
- Side Boards: custom built 1/8" aluminum diamond plate side boards tapered from top of cab protector to top of rear side pockets
- Paint: Single stage blue paint to best match cab, powder coat primer under finish paint.
- Load Cover: Fully automatic load cover with aluminum arms, asphalt tarp and wind deflector
- Additional Items: Mud Flaps, back-up alarm and federal 108 body lights

QUOTATIONS MUST INCLUDE THE FOLLOWING INFORMATION:

1. Complete description of vehicle with applicable printed material.
2. Guaranteed delivery time after receipt of written order.
3. Body will be accompanied by complete shop manual.
4. Bidder must list any deviations to the specifications

INSTALLATION:

1. The installer shall be responsible to ensure the proper location of the body on the truck to obtain the best working results. New Body must function with existing chassis.
2. The installation shall be performed following the state of the art. All required components shall be supplied by the installer.
3. All controls shall be in the cab within easy reach of the driver.
4. The City will remove the existing Body and paint frame rail before delivering chassis to successful bidder. (see picture of existing Chassis & Body attached)
