Vice Chairperson Doreen Gay called the meeting to order at 7:30 a.m.

Minutes: A motion to accept the November 2nd meeting was made by Kathy, seconded by Jessica and were accepted.

Election of new officers

Kathy motioned to elect the slate of officers as stated, seconded by Jessica and unanimously passed.

South Portland Gateway Design Proposal

Tex will be presenting the design proposal to the City Council on December 18th and he asked if AHPC would vote to endorse the plan. The three major elements of the design are: story line, gateposts and layered landscape. Following a discussion regarding potential light pollution and the sustainability of the design, Ashley made a motion to endorse the concept of the plan, with the knowledge that there will be further comment/discussion of details in the future. Kathy seconded and it was unanimously passed. Tex also asked if Hannah would attend the meeting on December 18th to show the AHPC’s support. If Hannah can’t make it, Doreen is available.

Redbank Celebration

With Adrian off the committee, no one really knows what is actually happening for this. This led to a discussion about the lack of representation in districts 4 and 5 on the committee. Adrian was the District 5 representative and now is the District 5 council member. It is hoped that he will quickly appoint a District 5 member to the committee. Jessica asked how the committee could become more visible to the community out there and Tex suggested that perhaps the committee could present a resolution celebrating the history of the area to the council. Doreen notes that Adrian mentioned that we should contact Mary DeRose regarding the Redbank celebration

Online Research Presentation by Kathy

Deed records of the Cumberland County Registry of Deed are online and can be accessed at:

Property searches cannot be conducted using the street address. The best way to begin is to have a book/volume and page number for the property. These are usually found at the end of the property description in a deed.

If you do not have a book/volume and page number, you can find that information at the South Portland Assessor's Office using the street address.

Once you have that information go to the Registry of Deeds website and choose: Recorded Land; Volume Search; Volume and Page Number. When you enter the Volume and Page Number it will bring up the document. You can then view the deed.

The language you are looking for is sale of "a certain lot of land with buildings there on". You then trace the property back until you come upon a deed which just says "a certain lot of land". When you find that deed you will have an approximate idea of when the building was built.

Round Robin
