Addendum #1

The is addendum answers several questions that were asked regarding the Curbside Collection RFP

- How many Road miles are there in the City?
 - There are approximately 160 center lane miles of road in South Portland
- Can you provide the addresses of the City buildings that will receive service and are the serviced with carts of front load?
 - The City buildings listed below are part of this RFP and are serviced with the cart system
 - Municipal Services Facility: 929 Highland Ave
 - South Portland High School: 637 Highland Ave
 - Central Fire Station: 684 Broadway
 - Cash Corner Fire Station; 360 Main St
 - West end Fiore Department: 34 James A Baka Dr
 - Planning Department: 496 Ocean St
 - South Portland City Hall: 25 Cottage Rd
 - Water Resource Protection: 1142 Highland Ave
 - Treatment Plant: 111 Waterman Dr.
 - South Portland Community Center 21 Nelson Rd
 - Redbank Community Center: 95 MacArthur Circle West
 - South Portland Library: 482 Broadway
 - South Portland Branch Library: 155 Wescott Rd
- In Section 2.0 Renewal of Contract: I'm assuming this is a typo, but want to clarify, "The rate increase for the sixth year shall be based upon the percentage increase, in the CPI-U, from July, 2011 to June, 2012. The rate increase for the seventh year shall be based upon the percentage increase, in the CPI-U, from July, 2012, to June, 2013." I assume the dates should read, July 2025, June 2026 and for the seventh year July 2026 to June 2027?
 - Strike all the language in Section 2.0 renewal of contract.
 - Section 2.0 renewal of contract shall read "The City of South Portland may elect to extend the contract one year at a time for up to 3 years. If the City elects to extend the contract it will be at a rate that is mutually agreed upon by the City and the Contractor.
- What Cart manufacturer does the City use?
 - The City uses Shaefer for both MSW and Recycling carts and uses Toter for recycling lids
- Can you provide MSW and recycling tonnage for 2-3 previous years?
 - The last two years tonnages are attached

- On Page 1 of the Agreement Specifications, 1. – It only mentions recyclables nothing is mentioned about MSW collection, this needs to be clarified.
 - Page 1 of the Agreement Specifications should include MSW and read as follows “The Contractor shall furnish all of the material and perform all of the work, shown on the drawings and described in the specifications entitled: RFP# 27-21 MSW and Recyclable Material Fully or Semi-Automated Curbside Collection Service, which are attached hereto and made part hereof and the Contractor covenants that it shall do everything required, by this Agreement, the Special Provisions of the Agreement, the Specifications, and drawings in return for payment, as provided herein:
- On the Schedule of Prices page, it is only asking for pricing for Single Stream Recyclable Collection pricing, nothing is mentioned about MSW, can you clarify?
 - This should read: “Collection of MSW and Reclables
 - 4 Day MSW and Single-Sort Recyclables Collection Price 7/1/2021-6/30/2022
 - 4 Day MSW and Single-Sort Recyclables Collection Price 7/1/2022-6/30/2023
 - 4 Day MSW and Single-Sort Recyclables Collection Price 7/1/2023-6/30/2024
 - 4 Day MSW and Single-Sort Recyclables Collection Price 7/1/2024-6/30/2025
 - 4 Day MSW and Single-Sort Recyclables Collection Price 7/1/2025-6/30/2026
